These boards plan, evaluate, and fund local mental health and addiction services and contract with various providers for their community members' prevention, treatment, and recovery support.

Strategic Highlights

Hope Town is positioned to bridge critical service gaps in Portage County. Our services improve outcomes for adults with addiction. Hope Town is a respected organization with a reputation for quality, innovation, grit, and goodwill. We have a diversified revenue system that supports stability and growth.

Financial Stability & Growth

In 2022, our revenue was \$300,000. 49% of our revenue came from Hope on Wheels, 28% from community donations, and 22% from recovery housing residents. Our income from Hope on Wheels has bolstered our financial position.

2023 & Beyond - Diverse Revenue Streams

- In 2023, we've diversified our financial structure, ensuring stability and growth opportunities. We are grateful for the annual state allocation of \$150,000 from OhioMHAS and \$150,000 from a county grant through the Mental Health & Recovery Board.
- Long-term partnerships, like the ten-year \$25,000 per year county grant and the five-year contract with the Portage County Jail, have added to our financial sustainability and improved our ability to serve the community effectively.

Our Board ensures the 501c3 organization is financially, legally and ethically sound.



For 35 years, her brother, Mark, struggled with alcohol and substance abuse, which ended up taking his life in October 2022. The years of ups and downs with his struggles to remain in recovery were hard on the entire family.

The following letter is from a Hope Town resident who has been in active recovery (clean & sober) since May 1, 2021!

I arrived at Hope Town on August 1, 2021. I didn't know what to expect. Things were not easy at first, but I was determined to try. I kept myself busy working the 12 steps of Alcoholics Anonymous with my sponsor, as well as helping around the house. It made me feel good about myself. Eventually, I was elected house manager, and it felt good to serve a role in making Hope Town an excellent place to live and recover. Ted told me he wanted Hope Town to be a peer-led organization. I didn't know what that looked like, but we all at Hope Town held each other accountable. It worked and still does.

In late 2021, I may have mentioned to Ted that he should start his own transportation company and do a better job getting people to their appointments, not making them wait hours to return home. I was having these issues with my medical transportation frequently. Of course, Ted, being Ted, he did precisely that, and Hope on Wheels was established.

I landed at Hope Town because Hope Town needed me, and I needed Hope Town. Hope Town has given me purpose, which I needed. I have learned so much about willingness, patience, and acceptance of others. Ted St. John has played a huge part in my recovery. I could not have made it to this point without him. I love him like a brother.

After about 13 months, I left Hope Town on September 10, 2022, and have my place locally. I continue to drive for Hope on Wheels, which I enjoy doing. Today, I do things that I enjoy, like hanging out with family, golfing, and watching movies. It's a good feeling to know I can do whatever I enjoy. I'll always be grateful to Hope Town, Ted St. John, Adam Ciganik, and all who supported my recovery.

Meet Adam

Adam Ciganik Program Director

Adam was raised as a Portage County resident by a single mother, a Sergeant Correctional Officer at the Portage County Jail. He was taught the importance of serving others with an empathetic perspective. These morals diminished as Adam's addiction rendered him powerless and a slave to compulsive, self-centered behavior.

From age 15, Adam's addiction continued to spiral out of control for over 20 years.

His mother passed away from cancer on Mother's Day, 2011, and he experienced untreated mental health as well. The years that followed consisted of I.V. heroin use, which produced consequences such as depression, isolation, homelessness, incarceration, drug overdose, suicide attempts, and the inability to maintain long-term employment.

On June 6, 2019, through an act of desperation and divine intervention, Adam decided he had suffered enough and admitted himself into residential treatment with the willingness to change. Adam decided to continue working in the construction trade throughout the first few years of recovery. He often found himself anticipating the moment he was done with the workday so he could help more people find recovery. He realized his soul's urge was to be of maximum service to others. He decided to follow his heart by changing his employment direction.

Adam worked for Hope Village as a certified Peer Recovery Supporter from 2021 until 2023. He was promoted to Jail Reentry Supervisor and Linkage & Navigation Coordinator. He then transferred to Hope Town, and we brought his programs. Now, he and his staff continue to help bridge gaps and navigate urgent needs when assisting individuals suffering from mental health and addiction.

A lifelong resident of Northeast Ohio, Neil has utilized his own experience with long-term recovery to fuel his motivation to help other people with addiction achieve their own life goals. Neil began working in the treatment field five years ago as an overnight monitor for a treatment center in Warren, Ohio, where he quickly realized that people with addiction in treatment

were being under-served. began running groups and individual sessions for New Day Recovery at their River Falls location. Looking for ways to innovate in the addiction treatment field, Neil worked his way to lead CDCA, where he was given the chance to start leaving his fingerprints on the program model itself.

Neil then left to join a start-up treatment center in Warren, Ohio, called Safe Harbor Recovery, where he worked with a team of talented individuals who believed in him enough to help him design the program model and settle into a new position: program coordinator.

Neil joins Hope Town as the Project Manager with a firm belief that every person with addiction has a voice that deserves to be heard and acknowledged, and he has made it his purpose to meet them where they are and attempt to guide them to a new life.

Realizing that addiction recovery has many different layers and that some regions of the recovery process are underserved, Neil was attracted to the vision of Hope Town to help those struggling with substance use disorders reintegrate into society with a plan for continued success and better odds at building the life they were always meant to live.

Recovery Housing

We offer two separate male and female peer-led social-model homes for adults with addiction. They are structured, clean, safe, affordable, and full of recovery support.



Employment Services

We partnered with Portage County Ohio Means Jobs to help our residents connect to meaningful employment with good pay based on their skill sets and preferences. They also provide transportation to and from work for up to six months. They help to purchase necessary clothing, tools, and other needs, as well as a lunch stipend.

Before his SUD treatment work, Ted enjoyed a diverse career path that included stints as a personal trainer, national-level bodybuilder, health club owner, and successful steel sales professional. Beyond his professional endeavors, Ted remains actively engaged in community service, serving on committees such as the Portage County Drug Task Force and the Trumbull County ASAP Coalition. Ted is pivotal in organizations like the Portage County Substance Abuse Coalition and the Portage County Specialty Dockets Advisory Board.

Additionally, Ted sits on the Board of Directors for Ohio Recovery Housing and the state's OneOhio Recovery Foundation, leveraging his expertise to advocate for those in need of support. Ted's commitment to service extends beyond his professional and advocacy roles, as evidenced by his honorable service in the U.S. Air Force as a Military Police officer.

Warm Welcome from Windham

Beyond the considerable volunteer hours invested in Hope Town, the community rallied to contribute washers, dryers, appliances, furniture, décor, and kitchenware. This outpouring of support reflects Windham's residents' genuine care and dedication. Despite initial concerns about potential opposition (NIMBY issues), the organization experienced a warm and supportive welcome from the community, dispelling any reservations.

Hope on Wheels Initiative (June 2022)

In June 2022, the organization expanded its impact by launching our Hope on Wheels program. This initiative, conceived by house manager Karl Yon, addresses the transportation needs of residents requiring access to critical life appointments, such as medical appointments and recovery support meetings. Recognizing gaps in local Medicaid rides, Hope Town, after rigorous credentialing and contracting procedures, stepped in to provide transportation services for community members covered by Medicaid insurance. This ensures crucial access to medical appointments and treatment services, further solidifying Hope Town's commitment to holistic care.

Hope Town in Ohio's Behavioral Health System

Hope Town plays a pivotal role as a contracted provider for the Mental Health & Recovery Board, aligning with Ohio MHAS's emphasis on fostering successful partnerships with community organizations, agencies, and boards. The organization actively engages in collaborative efforts, recognizing their significance in delivering effective mental health and addiction services. Within Hope Town, it aligns with regional behavioral health authorities and boards to plan, evaluate, and fund mental health and addiction services locally. This collaborative approach ensures a comprehensive continuum of care, meeting individuals at various stages of their journey to wellness.

Transportation

We are contracted and credentialed with eight insurance plans to provide rides to medical appointments and treatment services for residents and the rest of our Medicaid community. We have partnered with University Hospital, Portage County Adult Probation, and several treatment centers to provide rides for their patients/clients.

We also have some resources to help our residents initially with other transportation needs such as recovery meetings, grocery, recovery events, probation, court appointments, and even work (short-term).

Our Story

Reentry Services for Portage County Annates

We signed a 5-year contract with the PCSO for reentry planning and coordination. We have a strong relationship with the administration and are committed to helping inmates plan for release to improve chances for recovery. This, in turn, helps with recidivism, new charges, and compliance with community corrections.



Linkage & Navigation

We have 3-4 peer supporters trained to work in the jail and throughout our community to address urgent needs (housing, transportation, connection to treatment services).

Genesis of Hope Town Ohio

In the autumn of 2019, Hope Town Ohio was established through a transformative initiative fueled by a generous \$175,000 donation from the Regina Rebhan Foundation. The organization's roots took hold when Neighborhood Development Services (NDS), a local nonprofit, contributed to two townhouses in Windham, Ohio. Under the organization's guidance, these structures underwent restoration to become recovery housing facilities specifically designed for individuals seeking support for substance use and mental health disorders.

Community Collaboration: Building Hope Together

The creation of Hope Town was a collaborative endeavor that engaged the entire community. The interior restoration was predominantly done by dedicated volunteers, including skilled individuals and those passionate about the cause. Over a dozen events were organized, drawing participation from numerous volunteers, ranging from judges, commissioners, state representatives, police officers, probation officers, and drug court participants to teachers, administrative staff, church groups, friends, neighbors, and schoolchildren. Together, they orchestrated successful moving, cleaning, and painting parties, fostering a collective sense of accomplishment and purpose.
